- b) Carol moved to approve the May meeting minutes with corrections mentioned, Suzi seconded. All approved.

### 3) Video Clips

- a) Daniela mentioned she would like to receive approval from the Collaborative to record part of the meeting for HOPE Collaborative publications.
  - i) Anita moved to allow parts of the meeting to be recorded, Suzi Brown seconded. All approved.

### 4) Regional Collaborative Expenditures

- a) District Communities: Daniela provided the Collaborative with a copy of a map depicting the cities represented under District 2. It was explained that this year, the HOPE Board is requesting that the Collaborative councils spread out their efforts and attempt to extend their reach to more communities within the respective district.

      - (1) Victoria requested to invite Mel to come to a meeting and speak on what he is working on and see if we can help in those efforts.
        - i. Michelle C. suggested to focus on parent involvement and fathers can be included under that category.
        - ii. Anita S. mentioned the collaborative could donate books to the parent center for the workshops offered there for fathers.
        - iii. Anita suggested we table the focus area until the next meeting and invite Mel to come to speak on the existing father programs.

- 3) FY 2016-17 Focus area
  - a) Mel Campbell, Pastor and Teacher, provided a presentation on the *Dads All In Program*, which is being offered through Corona Norco Unified School District (CNUSD) Parent Center. This program is helping by creating a structure for father involvement to inspire, train and connect father figures in developing and nurturing positive interactions with their children. Currently, this program is active at 14 schools in CNUSD were there are 2 lead dads at each school who will be trained to lead the schools.
    - 1. Children participate and interact with dads on different activities, races, potato sack races, etc.
  - b) Anita reviewed the focus area ideas that were brought up at the last meeting as well as last year's focus areas, which included foster youth and at-risk middle school students. Anita suggested continuing with at-risk youth as a focus area. Victoria S. had mentioned at the last meeting looking at dad's roles.
    - 1. Father Roles, mentioning that this is why Mel was invited to speak on behalf of the efforts already being made through the *Dads all In Program*.
    - 2. At Risk youth/foster youth
      - (i) Jose mentioned that if District 2 decided to make at-risk youth their focus area they would be addressing all of the previously mentioned topics.
        - 1. Carol moved to select at-risk youth as the focus area for District 2, Jose seconded. All approved.
- 4) Regional Collaborative Expenditures
  - a) Budget Plan- Daniela reminded the Collaborative that the HOPE Board would like each collaborative to come up with a budget plan depicting where they will be spending their funding for the year.
    - Robin mentioned that last year the collaborative hosted a Teen Talk Conference for at-risk and
      foster middle school students. It was a success and it has been suggested to be done again and that
      more youth are invited by making it a 2 day conference.
      - (i) Jose mentioned that Jurupa Unified School District would like to get involved this year. He mentioned that last year JUSD was approached but did not provide a response.
        - 1. Jose mentioned that JUSD has 3 middle schools and transportation could be arranged for them to attend the conference.
      - (ii) Deanne reminded the collaborative to have efforts that focus on child abuse prevention at the conference.
        - 1. Daniela mentioned that last year she sat in several workshops and all were prevention focused. They addressed Internet Safety, Substance Abuse Prevention, Healthy Relationships, among many others.
      - (iii) Target for this conference are 7<sup>th</sup> and 8<sup>th</sup> grade students who are identified by school counselors.
